4.1 Ward Councillor John Harrington

The last cabinet meeting of Herefordshire Council outlined business.

Local Transport Plan needs refreshing

Future of the Public Realm Tech staff are coming back into HC offices (to be approved)

120 Asylum seekers are to be housed in the Three Counties Hotel Hereford (refugees Government Rules)

In 2022 £100m less revenue coming in. A serous situation, Government says HC must raise council Tax. JH says it is unfair to use capital for maintenance. They are currently £350m behind repairing highways.

JH explained that A and B roads receive priority over U & C roads due to the safety matrix the Council and BBLP use, meaning faster roads are rated as needing quicker repair. BBLP have different categories for risk for rural potholes and repair accordingly.

JH feels there are no answers to the reduction in revenue into the Council except to lobby government to return fairer funding.

### 4.2 To Note To receive views of Local residents on Parish Matters (10 minutes)

A member of the public made comments about a previous application which he wished had been reconsidered on issues of drainage etc. His comments and concerns about due process were noted. This application in a neighbouring ward (Kimbolton area North & Rural) has, we understand, has been requested to go to committee if officers are minded to approve by the ward Cllr. John Stone, Member for Leominster North and Rural. Cllr Harrington has confirmed that is his understanding after speaking to Cllr Stone but will seek confirmation.
